F.No.TIUT/01/07/RGST/2024-25-Admin/ 973 This is for information of all concerned that in context of the University Grants Commission's notification vide **D.O.No.13-19/2024(CPP-II)**, dated 11th September, 2024, relating to effective implementation of the **Tobacco-Free Educational Institution (ToFEI)** manual and guidelines, Techno India University, Tripura's (TIUT's) campus is hereby declared as a **Tobacco Free Campus**. The tobacco free campus policy defines tobacco products as including but not limited to **cigarettes, cigars, bidis, smokeless tobacco, chewing tobacco, hookah, and electronic cigarettes**. Individuals violating the policy may face strict disciplinary actions as per the university's code of conduct. The policy and its scope is described as under:-

1. The policy aims for a tobacco free campus.
2. The policy applies to all students, research scholars, faculty members, non-teaching staff members, casual workers and visitors.
3. Smoking/chewing tobacco products is strictly prohibited across the university campus including hostels, buses, canteens, playgrounds etc.
4. In case of visitors, they are to be made aware about the policy. They may either be requested not to smoke or be respectfully asked to leave the campus should they wish to smoke.
5. No smoking posters are to be displayed at all prominent places across the campus.
6. Awareness drives about usage of tobacco and its ill effects are to be conducted regularly.

Moreover, tobacco users are expected to adhere to the policy and be respectful and mindful towards non-tobacco users. **Dr. Animesh Bhattacharjee**, Assistant Professor, TIUT with additional charge of Security Officer, TIUT will be responsible for monitoring compliance of the policy and reporting of breaches if any.
